Letter from the Montana ELCA Synod

Dear Friends in Christ,

New Year's Greetings in the name of the Holy Trinity! Welcome to the new calendar year and the time of annual meetings in many of our congregations and ministries.

In her book How to Lead When You Don't Know Where You're Going: Leading a Liminal Season, Susan Beaumont describes the times and spaces the church lives in today as "liminal," as standing in the threshold of an open door to something new but we haven't gone through yet. In this space, part of us stands in the former things, part in the future things, and part in the right now, the right here, the confusing and messy "this."

This threshold is not an easy space/time for us to live in. As much as God seems to ask us through Isaiah's words that we should let go of the former things, humans caught up in the web of time and space just cannot do the impossible like God can.

In this threshold between already and not yet, we find both anxiety of an unknown future and the grief of losing a dying past that felt stable (whether it was stable is another question). In the threshold, we feel pushed by some to go too quickly into something we feel not yet ready for or we feel held back by those clinging too tightly to something that doesn't work anymore.

And in this threshold we find God. In fact, it's in the liminal spaces, the times we aren't in control, the times of not knowing and wonder that we actually find ourselves closer to God than any other time.

Why? Because this threshold happens when the layers of our self-constructed walls of our own agendas, plans and judgments are torn away and we are brought face-to-face with what God is revealing in the epiphanies of the new things God is declaring and doing. Skies are opened, the Savior is made known, the Spirit proclaims God's love for us and the whole creation, including you and me, are transformed into new creations. (So if anyone is in Christ, there is a new creation: everything old has passed away; see, everything has become new! 2Cor 5:17)

After the pandemic, many thought a new normal and a quick stability would settle in. Many today still seek, even demand, a fast-food resolution to the liminality in which we stand. But we're still standing in that threshold between the former things and the new possibilities, a time of both worry and wonder and we may be standing there for a while.

You too may be experiencing the anxiety of living in the threshold. We're still dealing with Covid and its effects as well as the flu, RSV, cancer, mental illnesses, addictions and other afflictions to body and mind. We still see the violence, polarization, disasters, fascism, anarchy, chaos and oppression of others on the news. We still fear the future unknowns as our minds go quickly to worst-case scenarios.

In our congregations, the Montana/N. Wyoming Synod and across the ELCA, we are experiencing economic anxiety about dwindling financial resources and, in our scarcity mindset, we ask if we have money to send to the wider church or pay our pastors or continue our generosity in serving in the wider world. We are also are concerned that the church, our church, is dying as fewer people are coming back to the pews and fellowship halls after the pandemic. We worry about a declining faith in Christ in the midst of so many who claim the title "Christian" but actually follow destructive philosophies and idols.

These reactions are understandable. I too am experiencing these anxieties and concerns as I consider the financial and social realities we are facing as we stand in the threshold. These are not easy times in which we live.

But in these times, I see God because I trust we are closer to God now than we were before. As our reliance on our own ways, goals and identities is peeled back layer by layer, we can begin to see more clearly God's presence with us and the new things that God has been, is and will be doing among us. We see through a glass dimly, for sure, but with open eyes, hearts and wills, we can see.

And not only does God appear more present to us during this time, but our Spirit-given faith (trust) tells us that "God is Able." This sermon title from Martin Luther King Jr. are words that I have been living with a lot over the past months: that God is indeed able. I think we forget that at times and begin to believe it is all up to us. But God is able to bring abundance out of scarcity. God is able to bring hope out of despair. God is able to bring life out of death. God is able to do all this and more again and again.

It's in the liminal spaces that the God-epiphany is revealed to us when we are open to seeing it. It's also in the liminal times that we need to cling to the promise that God is truly with us always, whether we feel it or not. And then, when we trust in this truth and the transformation that comes with it, we can participate in God's "new thing doings" by walking humbly with the God who is able, by doing our best to let go of the former things and by letting the Spirit work through Christ's Church to equip us for the ministry of the gospel.

I want to thank you for the ministry of the gospel you through each of your congregations and ministries have been doing in your threshold places in the Montana/N. Wyoming Synod. Thank you for the many resources, including the financial resources, you have shared with the synod, the ELCA and our ministries over the past year. These gifts are crucial to the equipping work we are doing with and for you. Thank you for the on-going service and generosity to "the least of these" through your love and justice work in your communities, this state and nation and across the world. And finally thank you for standing in the threshold with me so that we can support each other in these liminal times, sharing the new things from God that are springing forth around us.

May God bless you with new life, new possibilities and new hope in the year ahead!

I am pleased to report that we have worshiped together, in person, for the entire year of 2022. During the year we held an Ash Wednesday Service followed with Holden Evening prayer services during Lent. Holden Evening prayer services were used during Advent as well. Faith Lutheran with our Ecumenical Partners from the First Presbyterian Church, St Paul's Episcopal Church, Corvallis United Methodist Church and the United Methodist church in Stevensville held two services jointly in 2022. One during Pride month in June and the other during Advent. The five pastors from this group have been meeting on a regular basis since 2022. FLC also partnered with these churches and held a joint VBS in 2022. Please see Deb Cathey's report for more details.

There were 4 children baptized in 2022 and 2 Adults baptized. There were 8 new members received into membership either by transfer or through new members classes. Jacque Vandenburg, and Lans Richardson are into their second year of their Lay Pastoral Associate (LPA) program provided by the Montana Synod of the ELCA. They attended a preaching retreat in 2022. Following the retreat, Lans prepared and delivered a Christmas Day sermon. Jacque is preparing a sermon for Lent. Thank you to our LPA Rick Brown and to John Marten for helping to lead worship and preach during my absences.

I am honored and humbled to work with you in furthering the gospel of Jesus Christ as your pastor at Faith Lutheran Church.

2022 was a year of 'good news/bad news/good news' as far as developing a stronger program of discipling here at Faith. First, the good news:

Many opportunities for adult learning and growing in faith have been made available or continue. Golden Group held a Kogudus one day retreat and heard a presentation from the Council on Aging. A Woman's Book Study has enjoyed two great books this year. Thank you, Brooke! Men's Breakfast Is meeting regularly. Adult Sunday School meets as often as possible. Women's Circle Bible Study continues to meet once a month.

On the other hand, our children and youth are few and far between and we have no real means of meeting their faith needs on a regular basis. Vacation Bible School this year was very successful but that was really our only time with children and youth in any numbers.

• We're working on a solution:

We live in a changing world with changing priorities, so the question is 'How do we share Christ under these new conditions?'

So more good news...After much prayer and discussion, the best possibility seems to be hiring a full-time Youth and Family Associate. We're currently working on a clear and concise job description with salary and the offer of Faith House as a rectory. We need to work on finding funding for this position and hope that we can find someone in the congregation to help us look for grant type opportunities to help offset the cost of this position.

All of us, as the family of Faith need to be committed and available if we're to succeed.

The Lord be with you! As steward of outreach let me thank each and every one of you for the outreach work you do, knowingly or unknowingly. Your lives reach out like rays of Sonshine to a world that longs for joy and peace. Giant recognition and props for Linda Byer and her faithful crew who feed so many folks throughout the year with the ministry of monthly Community Meals. The faithfulness of this bunch is nothing short of phenomenal. Speaking of short phenomenons, thank you to the Quilters for their outreach of textile works of art to our young folks as they graduate High school and for the gift of quilts to the needy around the world. Our livestream worship services gathered about 1600 views in total over the year, averaging around 35 views per service. The Blessing of the Pets video received 195 hits, by far the most watched post. We live streamed one memorial service this year. I also lift up Pastor Paul and his outreach to the community. His grief groups have brought new folks into our circle, some who now call Faith their church. His guidance has caused the Mens' Bereavement Breakfast to grow, men from outside the church now meet here regularly for fellowship and support. Pastor Paul has reached out to our ecumenical partners and initiated the Pride Services and a cooperative Vacation Bible School program. Paul's work as Hospice Chaplain touches many lives in difficult times, and we are so grateful he is our pastor.

This year, a kitchen use calendar was created in google calendar to keep track of Kitchen use and avoid double booking our space. We continue to encourage people to contact the office to get their events on the calendar if they are using the Fellowship Hall and/or Kitchen.

The Scandinavian Dinner Survey was distributed and compiled to determine if we should continue to host a dinner and what format it should take. 43 surveys were returned with 28 respondents in favor of hosting the dinner. The respondent expressed varying offers of involvement. In December, Carol Peterson agreed to Chair the Scandinavian Dinner. She will host it this spring. Council agreed to holding the Scandinavian Fish Dinner on March 11, 2023.

Helen Volden and her crew provided meals a snacks for Vacation Bible School. Volunteers from the four churches hosting VBS worked together in the kitchen for another successful year of Bible School. Thank you to Helen and her great kitchen crew.

A big thank you to Dean and Sandy Drake who compiled a notebook with guidelines for past activities such as Easter Breakfast, Chili Cook off, etc. The notebook is currently stored in the Church office. With Jennifer Larson's help, I hope to add Kitchen procedures to the binder.

The Council plans to post our Mission Statement in the church. Brian Mendenall met with Pastor Paul, John Martin, and me to take measurements and discuss fonts for the signage. We continue to develop our plan and hope to have it completed in the spring of 2023.

Our Thrivent Funds saw a loss of \$35,130.03 for 2022. This of course limits our ability to utilize some of these funds. We have not been able to use any interest from two endowment funds because there is none.

In order to preserve the new parking lot we needed to have it resurfaced this year. An expected cost of \$2000-3000 became a \$14,884 cost due to inflation. The cost of the parking lot was covered by Capital Expenditures and help from the Endowment Committee. In addition we had some plumbing costs due to leakage of \$6680 paid from the General Reserve Fund.

In 2023 we anticipate the need to start replacing our 40-year-old boilers and we will need to decide how to pay for this. Costs are not yet available.

Thanks to Heather Wintergerst for her continued work in making sure the bills are paid and for answering my questions.

2022 Outreach Activities

"Love Day" Quilters

The Love Day Quilters meet to assemble quilts the first and third (plus any fifth) Wednesdays of each month. The quilts become local and world-wide outreach from our congregation.

In May 2022 144 quilts were shipped to the Lutheran World Relief clearinghouse in Minnesota. And currently there are another 73 completed for the next shipping date. In addition, 6 quilts were given to Faith's graduating High School seniors and 4 were donated to the Christmas family project. Anyone is welcome to attend the quilting sessions to help with making these quilts – no special skills are required.

Community Meals (sponsored by the Family Shelter of the Bitterroot)

Faith Lutheran has participated in the Community Meals program since its inception in 2013. We serve the meal on the 4th Tuesday of the month during the months of the year meals are served. We prepare meals at Faith in the early afternoon and then transport and serve the meals at the Cornerstone Church on Fairgrounds Road. We usually serve 75-80 Dine-In and Take Out meals each time we serve. In addition, any leftover food at the end of the meal is taken to the Massa Youth Home. Donations of time, money, and/or Thrivent Action Team assistance are appreciated to keep this helpful program viable.

Operation Christmas Child Shoeboxes (Samaritan's Purse)

Operation Christmas Child (OCC) Shoeboxes share God's love and the Christmas story with children around the world. This year Faith Lutheran Church members packed a total of 145 shoeboxes. A "Combo Party" was once again available with one week of an "On-Going" Packing Line allowing individuals and family groups to safely come to the church and fill shoeboxes. Then, an "After-Church" party that included food and fellowship happened at the end of that week. Golden Group

Emmaus Campus Ministry continues to thrive as an ELCA ministry working in partnership with the Episcopal, United Church of Christ, and Methodist congregations and denominations. Emmaus is a community living in the vision of Jesus' radical love and dignity for all people and life. Emmaus is a Reconciling in Christ group which means it is open and affirming to people of all gender and sexual identities and strives towards racial justice and equality in our world.

Student residents and staff: We currently have housing for 15 students living in three different houses including the Ark, Emmaus House, and the Wesley House. We have about 25-30 students or young adults who are active in some way with us. We continue to have a full-time campus pastor, Rev. John Lund. In addition we have a part-time administrator, Kristen Comstock: part-time development person (open): and a part-time racial justice advocate and organizer, Rai Combs. We have 3 student workers and 2 seminarians working part time with us this year.

Student Programs: The heart of our student group is our weekly dinners and discussions on Wednesday nights with an average of about 15 students. We also offering our contemplation community called Confluence on the first and third Sundays in the UCC sanctuary with an average of about 15 people of all ages. We hosted a winter retreat, spring break trip to Holden Village, a spring white water rafting retreat, summer rafting and hiking events and a fall retreat on the Blackfoot River. We also have taken on a number of local service projects through the year. We are gearing up for a winter retreat in February and a spring break trip service trip to Vancouver, BC.

Faith and Climate Action: Emmaus is the fiscal holder of this group and continues to support graduate student interns to help it run. This group is hosting a monthly speaker series called "Cultivating Wisdom: Re-imagining our relationships to the natural world."

Anti-Racism and Community Organizing Work: Pastor Lund is an active member of the MLK Day planning team Pastor Lund continues to be on the teaching team for a series called Wrestling with the truth of Colonization which is offered through Common Good Missoula. He also serves on the strategy team for CGM.

Buildings and Grounds: This summer we replaced 7 older windows at the Wesley House and took on smaller projects at Emmaus.
